



AIKAWA, Kazutoshi is Ambassador and Director-General of the Disarmament, Non-Proliferation and Science Department. His previous positions include Councillor of Cabinet Secretariat (Territorial Integrity), Deputy Director-General at the Economic Affairs Bureau and Latin American and Caribbean Affairs Bureau, Minister and Political Coordinator of the Permanent Mission of Japan to the U.N., and Minister and Deputy Chief of Mission at the Embassy of Japan in the Islamic Republic of Iran. As a former Director of the Regional Policy Division of the Asian and Oceanian Affairs Bureau at the Ministry of Foreign Affairs (MOFA) Asian regional architecture, Aikawa participated in the Japan-China-Korea East Asian Summit and Japan-ASEAN. He also participated in MOFA U.N. Reform and Security Council matters as the Director of the U.N. Policy Division of the Foreign Affairs Bureau. He has also served as Counsellor (Political) at the Permanent Mission of Japan at the U.N. and Counsellor (Economic/Development Division) at the Embassy of Japan in Malaysia. He received his B.A. in Faculty of Law from the University of Tokyo in 1983 and LL.M. from Columbia Law School in 1987.

ENKHSAIKHAN, Jargalsaikhan is Ambassador-at-Large of Mongolia. He represented his country at the United Nations in New York. Though a professional diplomat, he served as the legal and national security advisor to the first democratically elected President of Mongolia and, as such, in 1994, organized the drafting, consideration, and adoption by the State Great Hural (parliament) of the country's first national security and foreign policy concepts as well as the basis of its military policy. He has wide experience in nuclear issues. As the national coordinator for Mongolia's nuclear-weapon-free status, he represented Mongolia's interests at the United Nations and other international fora. Dr. Enkhsaikhan is a co-founder and Chairman of Blue Banner, a Mongolian NGO that is dedicated to promoting non-proliferation and nuclear disarmament in the Asia-Pacific region. He received his doctor's degree in international law in 1979 from the Moscow Institute for International Relations.

ENOMOTO, Koji is a Ph.D. candidate at the Hitotsubashi University Graduate School of Law, and a Research Fellow of the Japan-U.S. Partnership Program at the Research Institute for Peace and Security (RIPS). He is a member of Japan Student and Young Pugwash and worked at acting committee for the 61st Pugwash Conference on Science & World Affairs, Nagasaki 2015. His areas of interests are diplomatic policy and multilateral treaty regimes of arms control, disarmament, and non-proliferation of nuclear weapons. He has served as a Special Advisor for Comprehensive Nuclear-Test-Ban Treaty (CTBT) issues at the Permanent Mission of Japan to the International Organizations in Vienna (2011-2013) as well as the Office of Atomic Energy Policy Secretariat of the Japan Atomic Energy Commission as a Researcher (2015). Previously, he joined the Center for the Promotion of Disarmament and Non-Proliferation (CPDNP), Japan Institute of International Affairs (JIIA) as an

intern. He holds his B.A. in law from Kansai University and M.A. in international relations from International Christian University Graduate School of Public Administrations.

FUJIWARA, Kiichi is professor of International Politics at the University of Tokyo, teaching courses on international relations and international conflict at the Faculty of Law, Graduate Schools of Law and Politics, and the Graduate School of Public Policy, the University of Tokyo. A graduate of the University of Tokyo (B.A. and M.A.), Professor

Fujiwara studied as a Fulbright student at Yale University, before he returned to Japan at the Institute of Social Science (ISS). He first joined the faculty at Chiba University, and then returned to ISS for seven years before moving into the present position. He has held positions at the University of the Philippines, the Johns Hopkins University, and was selected as a fellow of the Woodrow Wilson International Center at Washington D.C. Professor Fujiwara is a regular commentator on international affairs and Japanese foreign policy on Japanese TV networks, along with the BBC World Service and CNN. He is also a film buff and occasionally writes columns on cinema for various journals.

HALPERIN, Morton H. is a Senior Advisor to the Open Society Foundations and the Open Society Policy Center. Dr. Halperin is on the Board of the Millennium Challenge Corporation. He served in the Clinton, Nixon and Johnson administrations, most recently as Director of the Policy Planning Staff at the Department of State (1998-2001). Dr. Halperin taught at Harvard (1960-66) and, as a visitor at other universities including Columbia, George Washington, and Yale. He has been affiliated with a number of other think tanks including the Center for American Progress, the Council on Foreign Relations, the Carnegie Endowment for International Peace, the Century Foundation and the Brookings Institution. He is the author of numerous books and articles including *Bureaucratic Politics and Foreign Policy*, *China and the Bomb*, and *Nuclear Fallacy*.

HAMEL-GREEN, Michael is Emeritus Professor in the College of Arts, Victoria University Melbourne, Australia. He was the former Dean Faculty of Arts, Education, and Human Development from 2008 to 2012. His teaching areas include international security, conflict resolution, and community development. His research has focused on regional nuclear-weapon-free-zones, nuclear non-proliferation, and multilateral negotiations. He is the Communications Editor of the *Routledge Journal, Global Change, Peace, and Security*; and the Convener of the Curatorial Committee of the newly established online Australian Living Peace Museum (livingpeacemuseum.org.au). His recent publications include: "Cooperating Regionally, Denuclearizing Globally: Multilateral Nuclear-Weapon-Free-Zone Initiatives" in Knopf, J. (ed) *International Cooperation on WMD Nonproliferation* (University of Georgia Press, Athens, 2016); "Australia's Disarmament Dilemma: Nuclear Umbrella or Nuclear-Free" (*International Law and Policy Institute*, 2014); "Peeling the orange: regional paths to a nuclear free world" (*Disarmament Forum*, UNIDIR),

2011; “Paths to Peace on the Peninsula: The Case for a Japan-Korea Nuclear Weapon Free Zone” (*Security Challenges*, 2011); and “Atomwaffenfreie Zone Arktis: Vorbilder und Perspektiven” (*Osteuropa*, 2011).

HAYES, Peter is an Executive Director at the Nautilus Institute for Security and Sustainability. He is also a Professor of International Relations at the Royal Melbourne Institute of Technology University in Australia and Director in Berkeley, California. He works at the nexus of security, environment, and energy policy problems. Best known for innovative cooperative engagement strategies in North Korea, he has developed techniques at Nautilus Institute for seeking near-term solutions to global security and sustainability problems and applied them in East Asia, Australia, and South Asia. Peter has worked for many international organizations including the UN Development Program, Asian Development Bank, and Global Environment Facility. He was founding director of the Environment Liaison Centre in Kenya in 1975. He has traveled, lived, and worked in Asia, North America, Europe and Africa. He has visited North Korea seven times. He was born in Melbourne Australia; today he is a dual national of Australia and the United States. He is married with two children.

VON HIPPEL, Frank is a nuclear physicist, a Senior Research Physicist, and Professor of Public and International Affairs emeritus at Princeton University where, in 1975, he co-founded and co-chaired for three decades what is now Princeton’s Program on Science and Global Security. During 1983-90, von Hippel worked with President Gorbachev’s science advisor, Evgenyi Velikhov, to develop a number of successful initiatives to end nuclear testing, the production of plutonium and highly enriched uranium for weapons, and eliminate excess weapons materials. In 2006, von Hippel co-founded the non-governmental International Panel on Fissile Materials (IPFM) in 2006 and co-chaired it for its first nine years. The IPFM includes experts from 18 countries and develops proposals for initiatives to reduce global stocks of plutonium and HEU and the numbers of locations where they can be found. He has advised U.S. Administrations and Congress on nuclear security issues since the Carter Administration. During 1993-4, he served as Assistant Director for National Security in the White House Office of Science and Technology Policy and played a major role in developing U.S.- Russian cooperative nuclear initiatives.

HIROSE, Satoshi is a Vice Director at the Research Center for Nuclear Weapons Abolition, Nagasaki University (RECNA). Prof. Hirose is co-editor of *Disarmament Review*, an annual issued by the Japan Association of Disarmament Studies. He used to serve for the United Nations Development Program as a program officer and for the Ministry of Foreign Affairs of Japan as a legal adviser to the Japanese Delegation to the Conference on Disarmament. He also participated in the Review and Extension Conference of the Nuclear Non-proliferation Treaty held in New York in 1995 as a member of the Japanese Delegation.

He has a broad background in disarmament issues as well as in international cooperation and development assistance.

HORIO, Kenta is a Ph.D. candidate at the Department of Nuclear Engineering and Management at the University of Tokyo. His areas of interest include nuclear energy policy, nuclear non-proliferation, and nuclear safety and security. Until June 2015, he served for two years as the special adviser to the Permanent Mission of Japan to the International Organizations in Vienna. He was also an adviser to the Japanese delegation to the 2015 NPT Review Conference. Previously, he was involved in research and analytical work at various organizations including the Ministry of Foreign Affairs, Japan Atomic Energy Agency, and International Atomic Energy Agency in parallel with his studies at graduate school. He was a member of the working group for the Independent Investigation Commission on the Fukushima Nuclear Accident, led by private think-tank Rebuild Japan Initiative Foundation. He received a M.E. in nuclear engineering and B.S. at the University of Tokyo.

JUN, Bong-Geun is Professor and Director of the Department of Security and Unification Studies at the Institute of Foreign Affairs and National Security (IFANS) in the Korean National Diplomatic Academy. Professor Jun held several governmental and non-governmental positions: Policy Advisor to the Minister of Unification (2003 – 2004), Secretary to the President for international security affairs at the Presidential Office (1993-1997), and a professional staffer at KEDO New York headquarters (1997-2001). Dr. Jun was also visiting fellow at Asia Foundation Center for U.S.-Korea Policy in Washington, D.C. (2010) and the Geneva Center for Security Studies in Geneva (2015). Dr. Jun's research area covers the North Korean nuclear issue, inter-Korean relations, nonproliferation, nuclear security, and nuclear energy policies.

JUN, Byungdug is a professor and a director of the Center for the Study of Peace and Multicultural Coexistence at the Department of Education of Nagasaki University, and a part time staff at the Research Center for Nuclear Weapons Abolition (RECNA), Nagasaki University. After he received his Dr. of Engineering (Remote Sensing) from Nagasaki University, he joined the Department of Engineering and Education as a lecturer and associate professor (1994-2008), Nagasaki University. He is an editor of "Spatial Information Research," an international journal for GIS and Remote Sensing. Prof. Jun has published more than 260 articles (in English and Japanese) covering the fields of engineering and peace education. His recent co-authored books include remote sensing matters: *The Yellow River, Water and Life* (New Jersey and London: World Scientific Publishing Co. Ltd., 2010) and peace education matters: *How to inherit the memories of the war* (Tokyo: Fuyoshobo Press, 2012 in Japanese).

KATAMINE, Shigeru is President of Nagasaki University (2008~). He received his Bachelor's Degree in Medicine at Nagasaki University School of Medicine (1976), and his Doctor of Medicine Degree at

Tohoku University Graduate School, Division of Medicine (1982). He was an International Research Fellow of the National Cancer Institute (1985), Associate Professor of the Nagasaki University School of Medicine (1991), and Professor of the Nagasaki University School of Medicine (1998). He is a virologist and one of the founding members of the Graduate School of International Health Development, School of Global Humanities and Social Sciences, and Research Center for Nuclear Weapons Abolition (RECNA), Nagasaki University.

KAWASAKI, Masahiro is Ambassador and Deputy Director-General of the Disarmament, Non-Proliferation and Science Department at the Ministry of Foreign Affairs. Previously, he has held many positions in the Ministry of Defense (MOD) including Deputy Director-General for Realignment Initiatives in the Minister's Secretariat, Director of Plans Department at the Technical Research and Development Institute, Director of Equipment Policy Division, Director of Human Resources Development Division, Director of Public Affairs Division, Director of Information and Communication and the Follow-up Research Division. He received his B.A. in Faculty of Engineering from the University of Tokyo in 1987, and joined the Japan Defense Agency after graduation.

KUROSAWA, Mitsuru is a professor of Osaka Jogakuin University. He received his B.A., M.A., and Ph.D. in Law at Osaka University. Formerly, he was a Professor in Faculty of Law at the Osaka School of International Public Policy, Osaka University; Visiting Scholar at University of Virginia (1980-1982) and Monterey Institute of International Studies (2003-2004); Founding President of Japan Association of Disarmament Studies (2009-2013); and Advisor to Japanese Delegation to the NPT Review Conferences in 1995, 2000, 2005, 2010 and 2015. Recent publications include: *Toward a World without Nuclear Weapons* (in Japanese, 2014) and *Introduction to Nuclear Disarmament* (in Japanese, 2011); and recent papers in English include: "2015 NPT Review Conference and Nuclear Disarmament", *Osaka University Law Review*, No.63, 2016; and "Humanitarian Approach to Nuclear Abolition", *Osaka University Law Review*, No.62, 2015.

LEWIS, Jeffrey is an Adjunct Professor and Director of the East Asia Nonproliferation Program at the James Martin Centre for Nonproliferation Studies (CNS). Before coming to CNS, he was the Director of the Nuclear Strategy and Nonproliferation Initiative at the New America Foundation. Prior to that, Dr. Lewis was Executive Director of the Managing the Atom Project at the Belfer Center for Science and International Affairs, Executive Director of the Association of Professional Schools of International Affairs, a Visiting Fellow at the Center for Strategic and International Studies and a desk officer in the Office of the Undersecretary of Defense for Policy. He is also a Research Scholar at the Center for International and Security Studies at the University of Maryland's School of Public Policy (CISSM). He is the author of *Paper Tigers: China's Nuclear Posture* and various other publications. He also publishes ArmsControlWonk.com, the leading blog on disarmament, arms control and nonproliferation.

MATSUKAWA, Hisakazu is the Director-General of Culture, Tourism and International Affairs Department of Nagasaki Prefectural Government. He also serves as Vice Chairman of PCU Nagasaki Council for Nuclear Weapons Abolition. Having graduated from Yokohama National University in March 1980, he began his professional career at the Nagasaki Prefectural Government. His previous positions at the Nagasaki Prefectural Government include the Head of Nagasaki Tourism and Local Products Promotion Center in Tokyo and Vice Director-General of Local Products Distribution Promotion Headquarters.

MITOH, Yoshifumi is the Deputy Mayor of Nagasaki City. After graduating from the Department of Science and Engineering, Saga University in March 1974, he began his professional career at the Nagasaki City Hall. He served in various posts including Director of the Welfare Department (April 2005) and Director of the General Affairs Department (August 2007). He was appointed as the Deputy Mayor of Nagasaki in July 2011.

MOON, Chung-In is a distinguished professor emeritus of Yonsei University. He is also editor-in-chief of *Global Asia*, a quarterly journal in English, co-convenor of APLN, and co-chair of the Korea Peace Forum. He served as Ambassador for International Security Affairs at the Ministry of Foreign Affairs and Trade. He served as Dean of Yonsei's Graduate School of International Studies and as Chairman of the Presidential Committee on Northeast Asian Cooperation Initiative, a cabinet-level post. He has published over 50 books and 300 articles in edited volumes and such scholarly journals as *World Politics*, *International Studies Quarterly*, and *World Development*. Moon accompanied the 2000 and the 2007 North-South Korean summit as a special delegate and was appointed as a member of president-elect Roh Moo-hyun's high level delegation to the U.S. in 2003. He served as Vice President of the International Studies Association of North America and president of the Korea Peace Research Association. Moon is serving as chairman of the board of Asia Research Fund and a board member of the East Asia Foundation. He served as a board member of Korea Foundation and the Sejong Foundation.

MUKAI, Wakana is currently Project Assistant Professor at the Security Studies Unit of the Policy Alternatives Research Institute (PARI) at the University of Tokyo. Before joining PARI, she worked as a research fellow at the Ocean Policy Research Foundation (2010-2013) as well as the Center for the Promotion of Disarmament and Nonproliferation, Japan Institute of International Affairs (2006-2008), as an intern, research associate, and research fellow, where she focused on nuclear nonproliferation and disarmament issues including the CTBT, nuclear-weapons-free zones, India and Pakistan, etc. Mukai holds her B.A. in language and area studies from Tokyo University of Foreign Studies, and her M.P.P and Ph.D. from the University of Tokyo.

MURAKAMI, Kenju is Director of the Arms Control and Disarmament Division. His previous positions include Cabinet Counselor, a position at the National Security and Crisis Management Office in the Cabinet Secretariat, Counselor at the Embassy of Japan in Egypt, First Secretary of the Permanent Mission of Japan to the United Nations, Principal Deputy Director in the FTA/EPA Division of the Economic Affairs Bureau, a position in the Human Rights and Humanitarian Affairs Division, and a position in the First North America Division of the North America Bureau. He joined the Ministry of Foreign Affairs of the Government of Japan in 1993. Before that, he received his Bachelor of Law from the University of Tokyo in 1993, and then later his LL.M. from the University of Michigan Law School in 1995 and M.A. in political science from the University of Michigan in 1996. In 2007, he co-authored the handbook for the EPA/FTA Negotiations titled “Kaisetsu FTA/EPA Koushou.”

NAGAI, Yuichiro is currently Project Researcher at the Policy Alternatives Research Institute (PARI) of the University of Tokyo. He is also working as Project Researcher at Graduate School of Public Policy (GraSPP) of the University of Tokyo. He received his Ph.D. in 2011 in International Relations from Nihon University. Before joining PARI, he taught International Relations at Nihon University. He was also a visiting scholar at the Space Policy Institute of the Elliot School of International Affairs, George Washington University, from 2008-2009. His research interests include international politics, U.S. diplomatic history, and space policy.

NAKAMURA, Keiko is an Associate Professor at the Research Center for Nuclear Weapons Abolition, Nagasaki University (RECNA). She also serves as the Japanese Coordinator of Parliamentarians for Nuclear Non-proliferation and Disarmament (PNND). In 2001, she joined the Peace Depot Inc., a Japanese non-profit, independent peace research institution which aims to build a security system that does not rely on military power, where she had served as Secretary-General from 2005-2012. She has written numerous articles in *Nuclear Weapons & Nuclear Tests Monitor* (Peace Depot’s bi-weekly periodical) and *Yearbook: Nuclear Disarmament and Peace*. She is a member of the Japan Association of Disarmament Studies and Japan Association of Peace Studies.

NIKITIN, Alexander I. is Director of the Center for Euro-Atlantic Security and Professor at Moscow State Institute for International Relations (MGIMO-University). Prof. Nikitin is also a Chief Researcher at the Institute for World Economy and International Relations (IMEMO), Russian Academy of Sciences; a member of the Scientific Council of the Security Council of Russia; and a member of the Scientific-Expert Council of the Collective Security Treaty Organizations (CSTO). He also serves as Deputy Chairman of the Russian Pugwash Committee of scientists and member of the International Pugwash Council, and as President Emeritus of the Russian Political Science Association.

OTA, Masakatsu is Senior and Editorial writer, and a former Washington correspondent at *Kyodo News*, a position he has held since April 2009. He reports on a variety of nuclear issues, non-proliferation, and the U.S.-Japan security relationship. Ota is the author of eight Japanese books on nuclear and security issues. He recently published *Nichibei Kaku Mitsuyaku no Zenbo* (The Whole Picture of the U.S.-Japan Secret Nuclear Deal) and *Nichibei Kaku Domei* (US-Japan 'Nuclear' Alliance). Ota was awarded the Vaughn-Uyeda Prize in April 2007 for his investigations into the history of the U.S.-Japan security relationship, the history of the Second World War, and his series of scoops on U.S. nuclear policy. He was also awarded the Peace Cooperative Journalist Fund Prize in December 2009 for his investigative reports into the secret U.S.-Japan nuclear deal during the Cold War. Ota received a B.A. in political science from Waseda University. He was awarded the Fulbright Scholarship in 1999 and conducted research at the University of Maryland from 1999 to 2000. He received a Doctorate from the National Graduate Institute for Policy Studies in Tokyo in 2010 for his research on U.S.-Japan nuclear policy.

RYDELL, Randy is Executive Advisor to the Hiroshima-based Mayors for Peace. He served from 1998 to 2014 as Senior Political Affairs Officer in the Office of the UN's High Representative for Disarmament Affairs, where he was Team Leader of its Strategic Planning Unit. He was an advisor to Angela Kane and four previous Under-Secretaries-General for Disarmament Affairs. From 2005 to 2006, he was Senior Counsellor and Report Director of the Weapons of Mass Destruction Commission (Blix Commission) and Senior Fellow at the Arms Control Association. He was Secretary of the Secretary-General's Advisory Board on Disarmament Matters (2001) and as a Visiting Lecturer at Princeton University (1998/1999, and 2009/2010). He received the "Unsung Heroes" award in 2009 from the Center for Non-Proliferation Studies at the Monterey Institute for International Studies. He also served as an adviser to US Senator John Glenn (1987-1998) and as an analyst at the Lawrence Livermore National Laboratory (1980-1986).

SHEN, Dingli is a professor and associate dean at Fudan University's Institute of International Studies. He is also an Honorary Visiting Professor of WUSTL. He has taught international security, China-US relations, China's foreign and defense policy in China, and the US and the "Semester at Sea" Program. His research and publications cover China-US security relations, regional security and international strategy, arms control and nonproliferation, and foreign and defense policy of China and the US, etc. He is Vice President of Chinese Association of South Asian Studies, Shanghai Association of International Studies and Shanghai Association of American Studies. He received his Ph.D. in physics from Fudan in 1989 and did his post-doc in arms control at Princeton University from 1989-1991. He is on the Global Council of Asia Society.

SHIRABE, Susumu is a Chairman, PCU Nagasaki Council for Nuclear Weapons Abolition. He is also vice president of Nagasaki University in charge of the university's social contribution initiatives. In

addition to being a neurologist, he also holds positions as professor at Nagasaki University Hospital and the Center for Campus Health and Community Medicine. He is a second-generation atomic bomb survivor: both his mother and his grandparents survived the bombing of Nagasaki; his grandparents have since passed away. Two of his uncles were killed in the atomic bombing when they were students. Dr. Shirabe has been a member of International Physicians for the Prevention of Nuclear War (IPPNW) for more than twenty years, and he is an international council member for the organization's Japanese affiliate.

SOLMESKY, Sergio Gabriel is General Secretary of the Brazilian-Argentine Agency for Accounting and Control of Nuclear Materials (ABACC) since January 2015.

He is Specialist in International Nuclear Policy and Nuclear Power Plant Safety, with a degree in Chemical Engineering from the Universidad Tecnológica Nacional (Argentina, 1974). His previous position and responsibilities were as Adviser of the General Secretary (2010/15) and Head of the Institutional Relations Office of the Nuclear Regulatory Authority of Argentina (2005/09), Adviser to the Presidency of the National Atomic Energy Commission (CNEA, Argentina, 2001/02) and Director of the Nuclear Regulatory Authority (ARN, Argentina, 2000/01). Other relevant career highlights are as Member of the Latin American Section of the American Nuclear Society (2015/16), Member of Argentina's national representation at the Treaty Review discussion of the Non Proliferation Nuclear Weapons Treaty (2005), Argentina's representative to the discussion and development of nuclear security policies in IAEA meetings (2006/09), and Ad-honorem Technical adviser to the Energy and Science and Technology Committees of the Camera of Deputies, Argentina (1992/99).

SON, Hyun-jin is Associate Professor of Hiroshima Peace Institute at the Hiroshima City University. He graduated from the Faculty of Law at the Pukyong National University in 1997, and received his M.A. and Ph.D. (Law) in Graduate School of Law at Kobe University in 2006. He served as a North Korean Human Rights experts in the Ministry of Unification in Korea Government (July 2006-February 2011), and as a Research Fellow at the Korea Legislation Research Institute (March 2011-March 2014). He specializes in international law, North Korean law, and the situation of the Korean Peninsula. His main research achievements are a *Review on the issue of South Korean Abductees and POWs (Prisoners of Wars)*, *Korean Journal of International Law*, 2013; a *Study on an a way to improve human rights for North Koreans after regime change in North Korea*, KINU, 2013; and a *North Korea under Kim Jon-Un Regime: Perspective on Nuclear and Abduction Issues* (Hiroshima Peace Research Journal, 2014.)

SUH, Jae-Jung is currently Professor at International Christian University (Tokyo, Japan). He has served as Associate Professor and Director of Korea Studies at SAIS, Johns Hopkins University, and Assistant Professor in Department of Government at Cornell University as well as on the Presidential Commission on Policy Planning (Republic of Korea). An expert on the U.S.-Korea relations, U.S. policy

toward Asia, international relations of East Asia, international security, and IR theory, he has authored and edited numerous journal articles and books, including *Power, Interest and Identity in Military Alliances*; *Rethinking Security in East Asia: Identity, Power and Efficiency*; *Truth and Reconciliation in the Republic of Korea*; *Origins of North Korea's Juche: Colonialism, War, and Development*; "The Imbalance of Power, the Balance of Asymmetric Terror: Mutual Assured Destruction (MAD) in Korea;" "Changes in U.S. Military Strategy and the U.S.-Korea Alliance;" and "The Two-Wars Doctrine and the Regional Arms Race: Contradictions in U.S. Post-Cold War Security Policy in Northeast Asia." He is a recipient of numerous grants and fellowships including SSRC-MacArthur Foundation Fellowship for Peace and Security in a Changing World and Woodrow Wilson International Center for Scholars. He received his Ph.D. and Master's in political science from the University of Pennsylvania and B.A. in physics from the University of Chicago.

SUZUKI, Tatsujiro is Director and Professor at the Research Center for Nuclear Weapons Abolition (RECNA) at Nagasaki University, Japan. Before joining RECNA, he was Vice Chairman of Japan Atomic Energy Commission (JAEC) of the Cabinet office from January 2010 to April 2014. Before this, he was Associate Vice President of the Central Research Institute of Electric Power Industry in Japan (1996-2009), Visiting Professor at the Graduate School of Public Policy at the University of Tokyo (2005-009), an Associate Director of MIT's International Program on Enhanced Nuclear Power Safety (1988-1993), and a Research Associate at MIT's Center for International Studies (1993-95), where he co-authored a report on Japan's plutonium program. He is also a Council Member of Pugwash Conferences on Science and World Affairs (2007-09 and from 2014~). Dr. Suzuki has a Ph.D. in nuclear engineering from Tokyo University (1988).

TAKAHARA, Takao is Professor of International Politics and Peace Research at Meiji Gakuin University, and currently the Director of the International Peace Research Institute at Meiji Gakuin University (PRIME). He is a council member for the Peace Studies Association of Japan, and is on the International Advisory Board of the Peace History Society. He also serves as a board member of the Lucky Dragon Museum (Tokyo) and for the registered non-profit organization Peace Depot (Yokohama). He has held Visiting Scholar positions at the Peace Studies Program at Cornell University (1991-93), the Program on General Disarmament at the University of Maryland (2000-01), as well as at the University of Helsinki (2010) and Monterey Institute of International Studies (2011). TAUE, Tomihisa is the Mayor of Nagasaki City. He currently serves as the President of the National Council of Japan Nuclear Free Local Authorities, Vice-President of the Mayor for Peace, President of the Nagasaki Prefecture Association of City Mayors, Chairperson of the Nagasaki Prefecture

Association of Municipalities, and Adviser to the Japan Association of City Mayors. Having graduated from the Faculty of Law, Kyushu University in March 1980, he began his professional career at the Nagasaki City Hall. He served as the Director of the Tourism Promotion Section, Tourism Department (April 2002) and Director of the Statistics Section, Planning Department (April 2004). He was elected as the 32nd Mayor of Nagasaki in April 2007 and the 33rd Mayor of Nagasaki in April 2011.

TOMONAGA, Masao is Professor Emeritus of Nagasaki University and Director Emeritus, Japanese Red Cross Nagasaki, Atomic Bomb Hospital. He was born in 1943 in Nagasaki City, where he encountered the second atomic bombing at 2.7 km from the hypocenter. After he graduated from Nagasaki University School of Medicine and became a physician, he majored hematology and radiation injury medicine. He found evidences that atomic bomb radiation caused life-long bodily effects and induced leukemia and cancers. He reported these findings at the 1st International Conference on Humanitarian Aspects of Nuclear Weapons held in Oslo in 2013 and also presented a research study on the various effects of the use of nuclear weapons at the 2nd Conference held at Nayarit, Mexico in 2014. He has been Chairman of Organizing Committee of the Nagasaki Global Citizen's Assembly for the Elimination of Nuclear Weapons since 2009.

UMEBAYASHI, Hiromichi is Visiting Professor and former Director of the Research Center for Nuclear Weapons Abolition, Nagasaki University (RECNA). He is also Special Advisor, former President and Founder of Peace Depot Inc., Japan. He is a Ph.D. holder in the field of Applied Physics from Tokyo University. After resigning from teaching in university in 1980, he became a fulltime campaigner and researcher for peace, disarmament, and human rights issues. In April 2012, when RECNA was established, he became its inaugural Director. He serves as the East Asian Coordinator of PNND (Parliamentarians for Nuclear Non-proliferation and Disarmament). He is the Chief-editor of the 2015 RECNA Report "Proposal: A Comprehensive Approach to a Northeast Asia Nuclear Weapon-Free Zone." Among his recent books are *Nuclear Weapon-Free Zones* (2012) from Iwanami Shoten, Japan and its updated Korean version (2014) from Booksea Publishing Co., ROK.
