AKIYAMA, Nobumasa is Professor at the Graduate School of Law and the Graduate School of International and Public Policy at Hitotsubashi University, and an Adjunct Research Fellow at Japan Institute of International Affairs. His other professional appointments include memberships in various governmental consultative groups and study groups at Ministries of Foreign Affairs and Defense, the Japan Atomic Energy Commission, and the Nuclear Regulatory Commission of Japan, and advisor to the Japanese delegation to the NPT Review Conferences. Professor Akiyama has published extensively and presented papers at various conferences on non-proliferation, Japan's national security and nuclear energy. He also worked on review of the Fukushima nuclear accident as a leader of the working group for the Independent Commission on the Investigation of the Fukushima Nuclear Accident, initiated by a private think-tank, Rebuild Japan Initiative Foundation. Recent publication includes "Japan's Nuclear Disarmament Dilemma," Gorge P. Schultz and James Goodby, *The War That Must Never Be Fought* (Stanford, the Hoover Institution, 2015), and "Can Japan Remain Committed to Nonproliferation?" *The Washington Quarterly*, Vol.36, No.2, 2013 (co-authored with Kenta Horio) as well as numerous Japanese publications on nuclear non-proliferation and arms control.

CHOI, Sungyeol is a nuclear engineer specialized at radioactive waste management and nuclear nonproliferation. He is an assistant professor of nuclear engineering in Ulsan National Institute of Science and Technology (UNIST), South Korea. He was a senior researcher at Division of Nuclear Fuel Cycle Technology Development, Korea Atomic Energy Research Institute. From 2010 to 2012, he was a research fellow at Belfer Center for Science and International Affairs, John F. Kennedy School of Government, Harvard University. He earned Ph.D. in Nuclear Engineering in 2012 and B.S. in Nuclear Engineering (summa cum laude) in 2008 from Seoul National University. In 2008, he authored Lessons Learned from the Development of the Korean Nuclear Power Programme for the IAEA. He has published several peer-reviewed articles related to molten-salt pyroprocessing, fast reactors, nuclear waste disposal, nuclear nonproliferation, and nuclear fuel cycle system analysis.

ENKHSAIKHAN, Jargalsaikhan is Ambassador-at-Large of Mongolia. He represented his country at the United Nations in New York. Though professional diplomat, he served as the legal and national security advisor to the first democratically elected President of Mongolia and, as such, in 1994 organized the drafting, consideration and adoption by the State Great Hural (parliament) of the country's first national security and foreign policy concepts as well as the basis of its military policy. He has wide experience in nuclear issues. As the national coordinator for Mongolia's nuclear-weapon-free status he represented Mongolia's interests at the United Nations and other international fora. Dr. Enkhsaikhan is a co-founder and Chairman of Blue Banner, Mongolian NGO that is dedicated to promoting non-proliferation and nuclear disarmament in the Asia-Pacific region. He received his doctor's degree in international law in 1979 from the Moscow Institute for International Relations.

ENOMOTO, Koji is a Ph.D. student at the Hitotsubashi University Graduate School of Law, and a Research Fellow of the Japan-U.S. Partnership Program at Research Institute for Peace and Security (RIPS). He is a member of Japan Pugwash and acting committee for 61st Pugwash Conference on Science & World Affairs Nagasaki 2015. His areas of interests are diplomatic policy and multilateral treaty regimes of arms control, disarmament and non-proliferation of nuclear weapons. He has served as a Special Advisor for Comprehensive Nuclear-Test-Ban Treaty (CTBT) issues at the Permanent Mission of Japan to the International Organizations in Vienna from 2011 to 2013 and, a Researcher at the Office of Atomic Energy Policy Secretariat of the Japan Atomic Energy Commission in 2015. Previously, He involved in the Center for the Promotion of Disarmament and Non-Proliferation (CPDNP) as an intern. He received B.A. in Law from Kansai University, M.A. in International Relations from International Christian University Graduate School of Public Administrations.

HAMEL-GREEN, Michael is Emeritus Professor in the College of Arts, Victoria University Melbourne, Australia. He was the former Dean Faculty of Arts, Education and Human Development from 2008 to 2012. His teaching areas include international security, conflict resolution, and community development. His research has focused on regional nuclear-weapon-free-zones, nuclear non-proliferation, and multilateral negotiations. He is the Communications Editor of the Routledge journal, *Global Change, Peace and Security;* and the Convenor of the Curatorial Committee of the newly established online Australian Living Peace Museum (*livingpeacemuseum.org.au*). His recent publications include: *Cooperating Regionally, Denuclearizing Globally: Multilateral Nuclear-Weapon-Free-Zone Initiatives* in Knopf, J. (ed) *International Cooperation on WMD Nonproliferation* (University of Georgia Press, Athens, 2016), *Australia's Disarmament Dilemma: Nuclear Umbrella or Nuclear-Free* (International Law and Policy Institute, 2014); *Peeling the orange: regional paths to a nuclear free world* (Disarmament Forum, UNIDIR), 2011; *Paths to Peace on the Peninsula: The Case for a Japan-Korea Nuclear Weapon Free Zone*" (Security Challenges, 2011); and *Atomwaffenfreie Zone Arktis: Vorbilder und Perspektiven* (Osteuropa, 2011).

HAYES, Peter is an Executive Director, Nautilus Institute for Security and Sustainability. He is also a Professor of International Relations, Royal Melbourne Institute of Technology University, Australia and Director, in Berkeley, California. He works at the nexus of security, environment and energy policy problems. Best known for innovative cooperative engagement strategies in North Korea, he has developed techniques at Nautilus Institute for seeking near-term solutions to global security and sustainability problems and applied them in East Asia, Australia, and South Asia. Peter has worked for many international organizations including UN Development Programme, Asian Development Bank, and Global Environment Facility. He was founding director of the Environment Liaison Centre in Kenya in 1975. He has traveled, lived, and worked in Asia, North America, Europe and Africa. He has visited North Korea seven times. He was born in Melbourne Australia; today he is a dual national of Australia and the United States. He is married with two children.

HIROSE, Satoshi is a Vice Director, Research Center for Nuclear Weapons Abolition, Nagasaki University (RECNA) Prof. Hirose is co-editor of 'Disarmament Review', an annual issued by the Japan Association of Disarmament Studies. He used to serve for the United Nations Development Programme as a programme officer and for the Ministry of Foreign Affairs of Japan as a legal adviser to the Japanese Delegation to the Conference on Disarmament. He also participated to the Review and Extension Conference of the Nuclear Non-proliferation Treaty held in New York in 1995 as a member of Japanese Delegation. He has a broad background in disarmament issues as well as in international cooperation and development assistance.

HORIO, Kenta is a Ph.D candidate at the Department of Nuclear Engineering and Management, the University of Tokyo. His areas of interests includes nuclear energy policy; nuclear non-proliferation; and nuclear safety and security. Until June 2015, he served for two years as the special adviser to the Permanent Mission of Japan to the International Organizations in Vienna. He was also an adviser to Japanese delegation to the 2015 NPT Review Conference. Previously, he involved in research and analytical works at various organizations including Ministry of Foreign Affairs, Japan Atomic Energy Agency and International Atomic Energy Agency in parallel with his study at graduate school. He was a member of the working group for the Independent Investigation Commission on the Fukushima Nuclear Accident, led by private think-tank, Rebuild Japan Initiative Foundation. He received M.E. in nuclear engineering and B.S. at the University of Tokyo.

JUN, Bong-Geun is Professor and Director of the Department of Security and Unification Studies at the Institute of Foreign Affairs and National Security (IFANS) in the Korean National Diplomatic Academy Professor Jun held several governmental and non-governmental positions: Policy Advisor to the Minister of Unification (2003 – 2004); Secretary to the President for international security affairs at the Presidential Office (1993-1997); and a professional staffer at KEDO New York headquarters (1997-2001). Dr. Jun was also visiting fellow at Asia Foundation Center for U.S-Korea Policy in Washington, D.C. (2010) and Geneva Center for Security Studies in Geneva (2015). Dr. Jun's research area covers the North Korean nuclear issue, inter-Korean relations, nonproliferation, nuclear security and nuclear energy policies.

JUN, Byungdug is a professor and a director of the Center for the Study of Peace and Multicultural Coexistence at the Department of Education of Nagasaki University, and a part time staff at the Research Center for Nuclear Weapons Abolition (RECNA), Nagasaki University. After received his Dr. of Engineering (Remote Sensing) from the Nagasaki University, he joined the Department of Engineering and Education as a lecturer and associate professor (1994-2008), Nagasaki University. He is an editor of "Spacial Information Research", an international journal for GIS and Remote Sensing. Prof. Jun has published more than 260 articles (in English and Japanese) covering the fields of engineering and peace education. His recent co-authored books include remote sensing matters: The Yellow River, Water and Life (New Jersey and London: World Scientific Publishing Co. Ltd., 2010) and peace education matters: How to inherit the memories of the war (Tokyo: Fuyoshobo Press, 2012 in Japanese).

KULACKI, Gregory is China Project Manager, Union of Concerned Scientists (UCS). He is an expert on cross-cultural communication between the United States and China. Since joining UCS in 2002, he has promoted dialogue between experts from both countries on nuclear arms control and space security and has consulted with Chinese and U.S. governmental and non-governmental organizations, including the U.S. House China Working Group, the Senate Armed Services Committee, the U.S. National Academies, NASA, and the Office of Science and Technology Policy. Over the last decade, Kulacki has been cited by a number of U.S. and Chinese news organizations, including the Christian Science Monitor, Nature, New York Times, NPR, Washington Post, and Washington Times. Dr. Kulacki, who is fluent in Mandarin Chinese, has lived and worked in China for more than 20 years. Prior to joining UCS, he served as an associate professor of government at Green Mountain College, director of external studies at Pitzer College, and director of academic programs in China for the Council on International Educational Exchange. Dr. Kulacki earned a doctorate degree in political theory and a master's degree in international relations from the University of Maryland in College Park. He also completed graduate certificates in Chinese economic history and international politics at Fudan University in Shanghai.

MUKAI, Wakana is currently Project Assistant Professor at the Security Studies Unit of the Policy Alternatives Research Institute (PARI), the University of Tokyo. Before joining PARI, she worked as a research fellow at the Ocean Policy Research Foundation (2010-2013) as well as the Center for the Promotion of Disarmament and Nonproliferation, Japan Institute of International Affairs (2006-2008), as an intern, research associate, and research fellow, where she focused on nuclear nonproliferation and disarmament issues including the CTBT, nuclear-weapons-free zones, India and Pakistan, etc. Mukai holds her B.A. in language and area studies from Tokyo University of Foreign Studies, and her M.P.P and Ph.D. from the University of Tokyo.

NAGAI, Yuichiro is currently Project Researcher at the Policy Alternatives Research Institute (PARI) of the University of Tokyo. He is also working as Project Researcher at Graduate School of Public Policy (GraSPP) of the University of Tokyo. He received his Ph.D. in 2011 in International Relations from Nihon University. Before joining PARI, he taught International Relations at Nihon University. He was also a visiting scholar at the Space Policy Institute of the Elliot School of International Affairs, George Washington University, in the 2008-2009 period. His research interests include international politics, U.S. diplomatic history, and space policy.

NAKAMURA, Keiko is an Associate Professor, Research Center for Nuclear Weapons Abolition, Nagasaki University (RECNA) She also serves as the Japanese Coordinator of Parliamentarians for Nuclear Non-proliferation and Disarmament (PNND). In 2001, she joined the Peace Depot Inc., a Japanese non-profit, independent peace research institution which aims to build a security system that does not rely on military power, where she had served as Secretary-General from 2005-2012. She has written numerous articles on Nuclear Weapon & Nuclear Test Monitor' (Peace Depot's bi-weekly periodical) and, Yearbook: Nuclear Disarmament and Peace.' She is a member of the Japan Association of Disarmament Studies and Japan Association of Peace Studies.

NISHIDA, Michiru is Special Assistant for Disarmament and Non-Proliferation Policy of the Ministry of Foreign Affairs of Japan (MOFA) since 2007. He is currently Deputy Director and serves as Head of Disarmament Unit in the Arms Control and Disarmament Division since July 2011. Before this current assignment, he served from 2006 as First Secretary to the Delegation of Japan to the Conference on Disarmament in Geneva, mainly in charge of nuclear issues as well as space security issues.

Before being posted to Geneva, Mr. Nishida served as Head of the Export Control Unit of the Non-Proliferation, Science and Nuclear Energy Division of the Ministry of Foreign Affairs. He was also in charge of NPT, IAEA, MNA (Multilateral Nuclear Approaches to the Nuclear Fuel Cycle), PSI (Proliferation Security Initiative), SUA amendment, etc. He was a member of the Japanese delegation to the Six-Party Talks in 2005 on the occasion of agreement on the Joint Statement.

Mr. Nishida was sent to Monterey Institute of International Studies (Center for Non-Proliferation Studies) by the Ministry of Foreign Affairs of Japan to study non-proliferation matters. He graduated from the Monterey Institute in 1999 and earned an M.A. in International Policy Studies with a certificate on non-proliferation studies. He then served as Head of the Political Section of the Consulate-General of Japan to Karachi, Pakistan.

PAIK, Haksoon is a Senior Fellow, Director of the Center for North Korean Studies, and a Vice President for Education and Training at the Sejong Institute in South Korea. He received his Ph.D. in Political Science from the University of Pennsylvania, and was a post-doctoral fellow at Harvard University.

He is an advisor to the Kim Dae-jung Peace Center and the Executive Director of the Korea Peace Conference of the Korean Peace Forum. He was formerly the Chairman of South Korea's Ministry of Unification's Policy Evaluation Committee, a policy advisor to South Korea's Ministry of Foreign Affairs, the Executive Director of the Seoul-Washington Forum, and the Chairman of the Policy Committee of the Korean Council for Reconciliation and Cooperation (KCRC).

He has written extensively on North Korean politics, inter-Korean relations, Korean unification, Korean peace settlement, and North Korea-U.S. relations including the North Korean nuclear issue. He is author of numerous books and monographs: North Korean Politics in the Kim Jong Un Era, 2012-2014: Ideas, Identities, and Structures (2015), The U.S.-North Korea Relations during President Obama's Second Term, 2013-2014: Threat of the Use of Nuclear Weapons and the Collapse of Relations (2014), The U.S.-North Korea Relations during President Obama's First Term, 2009-2012 (2012), The Military in the North Korean Politics: Its Character, Status, and Role (2011), The History of Power in North Korea: Ideas, Identities, and Structures (2010), etc.

PAN, Zhenqiang (Retired) is currently Senior Adviser to China Reform Forum (CRF). He is also Director of Research Institute for Strategy and Management of the Central University of Finance and Economics in China; and adviser to the College of Defense Studies, National Defense University, PLA, China, among other social responsibilities. General Pan joined the PLA in 1963, and served in the Department of the General Staff for over two decades, having different responsibilities. After 1986, he was research fellow, deputy director, and director at the Institute of Strategic Studies of the National Defense University (NDU) until the retirement in August 2001. General Pan has been research fellow at a number of US universities, including the U.S. National Defense University (1987), Stanford University (1988-1989), Harvard University (1999 and 2000 respectively), and University of Georgia (2014). He is now Member of the Council of Pugwash Conferences on Science and World Affairs.

RYDELL, Randy is Executive Advisor to the Hiroshima-based Mayors for Peace. He served from 1998 to 2014 as Senior Political Affairs Officer in the Office of the UN's High Representative for Disarmament Affairs, where he was Team Leader of its Strategic Planning Unit. He was an advisor to Under-Secretary-General Jayantha Dhanapala and his four successors. From 2005 to 2006, he was Senior Counsellor and Report Director of the Weapons of Mass Destruction Commission (Blix Commission) and Senior Fellow at the Arms Control Association. He was Secretary of the Secretary-General's Advisory Board on Disarmament Matters (2001) and as a Visiting Lecturer at Princeton University (1998/1999, and 2009/2010). He received the "Unsung Heroes" award in 2009 from the Center for Non-Proliferation Studies at the Monterey Institute for International Studies. He also served as an adviser to US Senator John Glenn (1987-1998) and as an analyst at the Lawrence Livermore National Laboratory (1980-1986).

SHEN, Dingli is a professor and associate dean at Fudan University's Institute of International Studies. He is also an Honorary Visiting Professor of WUSTL. He has taught international security, China-US relations, China's foreign and defense policy in China, the US and the "Semester at Sea" Program. His research and publication covers China-US security relations, regional security and international strategy, arms control and nonproliferation, foreign and defense policy of China and the US etc. He is Vice President of Chinese Association of South Asian Studies, Shanghai Association of International Studies and Shanghai Association of American Studies. He received his Ph.D. in physics from Fudan in 1989 and did post-doc in arms control at Princeton University from 1989-1991. He is on the Global Council of Asia Society.

SHIRABE, **Susumu** is a Chairman, PCU Nagasaki Council for Nuclear Weapons Abolition. He is also vice president of Nagasaki University in charge of the university's social contribution initiatives. In addition to being a neurologist, he also holds positions as professor at Nagasaki University Hospital and the Center for Campus Health and Community Medicine.

He is a second-generation atomic bomb survivor: both his mother and his grandparents survived the bombing of Nagasaki; his grandparents have since passed away. Two of his uncles were killed in the atomic bombing when they were students. Dr. Shirabe has been a member of International Physicians for the Prevention of Nuclear War (IPPNW) for more than twenty years, and he is international council member for the organization's Japanese affiliate.

SON, Hyun-jin is Associate professor of Hiroshima Peace Institute, Hiroshima City University. He graduated from the Faculty of Law, Pukyong National University in 1997, an MA and Ph.D(Law) in Graduated School of Law, Kobe University in 2006. He served as a North Korean Human Rights experts, the Ministry of Unification, in Korea Government (July 2006-February 2011), a Research Fellow, at the Korea Legislation Research Institute (March 2011- March 2014). He specializes in International Law, North Korean Law, situation of the Korean Peninsula. His main researce achievements is a 「Review on the issue of South Korean Abductees and POWs(Prisoners of Wars)」[Korean Journal of International law, 2013] and a 「Study on an a way to improve human rights for North Koreans after regime change in North Korea J [KINU, 2013]. and a 「North Korea under Kim Jon-Un Regime: Perspective on Nuclear and Abduction Issues」(Hiroshima Peace Research Journal, 2014)

SUH, Mark B. M. is a political scientist from South Korea. He taught graduate level courses on East Asian security issues at the Free University of Berlin for more than 20 years until his retirement in 2011. He was a special adviser to South Korean governments on North Korea from 1998 to 2007. He is a member of the Pugwash Council since 1997 and the German Council on Foreign Relations since 2012. He was a visiting scholar at the Institute for Security and Development Policy (ISDP), Stockholm in 2013. He visits North Korea frequently since 2001 and is involved in capacity building projects for North Korea n scientists on energy and environmental issues.

SUZUKI, Tatsujiro is a Director, Professor of Research Center for Nuclear Weapons Abolition (RECNA) at Nagasaki University, Japan. Before joining RECNA, he was a Vice Chairman of Japan Atomic Energy Commission (JAEC) of the Cabinet office from January 2010 to April 2014. Until then, he was an Associate Vice President of the Central Research Institute of Electric Power Industry in Japan (1996-2009) and Visiting Professor at the Graduate School of Public Policy, University of Tokyo (2005-009), an Associate Director of MIT's International Program on Enhanced Nuclear Power Safety from 1988-1993 and a Research Associate at MIT's Center for International Studies (1993-95) where he co-authored a report on Japan's plutonium program. He is also a Council Member of Pugwash Conferences on Science and World Affairs (2007-09 and from 2014~). Dr. Suzuki has a PhD in nuclear engineering from Tokyo University (1988).

TAKAHARA, Takao is Professor of International Politics and Peace Research at Meiji Gakuin University, and currently the Director of International Peace Research Institute Meiji Gakuin University (PRIME). He is a Council member for the Peace Studies Association of Japan, and is on the International Advisory Board of the Peace History Society. He also serves as a board member of the Lucky Dragon Museum (Tokyo) and for the registered non-profit organization Peace Depot (Yokohama). He has held Visiting Scholar positions at the Peace Studies Program, Cornell University (1991-93), the Program on General Disarmament, University of Maryland (2000-01), as well as at the University of Helsinki (2010) and Monterey Institute of International Studies (2011). His recent writings include "Overcoming the Cold War Mindset: A Case for Promoting a Nuclear-Weapons Convention and a Nuclear-Weapon-Free Zone," Su Hoon Lee, ed., NORTHEAST ASIA'S NUCLEAR CHALLENGES (Seoul: Kyungnam University Press, 2013), pp.201-220.

Weapons Abolition, Nagasaki University (RECNA). He is also Special Advisor, Former President & Founder of Peace Depot Inc., Japan. He is a PhD holder in the field of Applied Physics from Tokyo University. After resigning from teaching in a university in 1980, he became a fulltime campaigner and researcher for peace, disarmament and human rights issues. In April 2012, when RECNA was established, he became its inaugural Director. He serves as the East Asian Coordinator of PNND (Parliamentarians for Nuclear Non-proliferation and Disarmament). He is the Chief-editor of the 2015 RECNA Report "Proposal: A Comprehensive Approach to a Northeast Asia Nuclear Weapon-Free Zone". Among his recent books are "Nuclear Weapon-Free Zones" from Iwanami Shoten and its updated Korean version "비 핵무기지대".

YI, Kiho is a professor of Political Science at Hanshin University and executive director of the Center for Peace and Public Integrity (CPPI) at Hanshin University. Previously, Yi worked as director of Nautilus ARI at Seoul between 2008 and 2012 and also secretary general of the Korea Peace Forum from 2003 to 2006, focusing on peace and cooperation issues between North and South Korea in the context of Northeast Asian cooperation. He also served as an advisory member of the Presidential Committee of the Northeast Asia Initiative. From 1999 to 2002, Yi was a visiting scholar at Waseda University in Japan, looking at the local/transnational civil movement and its links to peace in East Asia. Before 1999, he worked for ten years in the Korea Christian Academy, where he focused on Korean political change and global peace networks. In 1997, Yi completed his Ph.D. dissertation, titled "Social Movement Networks in the Democratization Process of Korea" at Yonsei University.
