This is a reflection of the wish of citizens living in Nagasaki Prefecture and Nagasaki City that Nagasaki should be the last city in human history which is subject to a nuclear attack.

PCU-NC constitutes of Nagasaki Prefecture, Nagasaki City and Nagasaki University as regular members and Nagasaki Foundation for Promotion of Peace and Nagasaki National Peace Memorial Hall for the Atomic Bomb Victims as special members.

Message from Chairman

In April, Nagasaki University gave birth to a new research center, possibly the first of its kind which bears the phrase "nuclear weapons abolition." The launching of the Research Center for the Nuclear Weapons Abolition (RECNA) 67 years after Nagasaki University experienced an atomic bombing was driven by wishes of the university and citizens in the atomic bombed city and also stimulated by the recent world trend, spurred by U.S. President Obama's speech in Prague, towards a world free from nuclear weapons.

Guided by the outcomes of research by RECNA, PCU-NC was established in collaboration with Nagasaki City and Nagasaki Prefecture to open a path toward the abolition of nuclear weapons.
